## **2022-2023 LRF Patient Programs COVID-19 Safety, Travel and Cancellation Policy** Updated December 19, 2022

## **Event Cancellation**

- LRF is unable to offer a hybrid version of these programs. If LRF is unable to hold the program in person as scheduled, alternate virtual plans will be communicated to all attendees as far in advance as possible.
- LRF also requests that you do not attend a Workshop or the Educational Forum if the attendee A) test
  positive for COVID-19or are exposed to someone who subsequently tests positive for COVID-19 in the 14
  days period before the Workshop or the Educational Forum or B) are actively experiencing symptoms of
  COVID-19 on event day.

## Vaccination

- All LRF staff, faculty, and program participants must show proof vaccination and protected against COVID-19 as defined by the Centers for Disease Control and Prevention (you are **up to date** with your COVID-19 vaccines when you have received the primary series *or* a booster within the last 12 months). All attendees to the program will be required to adhere to LRF's health and safety guidelines.
- All participants must provide proof of vaccination to LRF to attend the program. You may upload proof of
  vaccination prior to the program or show proof of vaccination on site. Additional direction on uploading proof of
  vaccination status will be provided in advance of the program. Attendees who are unable to provide proof of
  vaccination will be denied entry to the event.

**On-Site Health Policy** 

- Personal protective equipment (masks), hand sanitizer and contactless check-in made available.
- LRF Lymphoma Workshop and Educational Forum venues will allow for social distancing. In addition, LRF may limit attendance due to venue capacity and to ensure social distancing.
- Attendees who are lymphoma/CLL patients in active treatment or who have received immunosuppressive medications or treatments in the past 6 months are required to wear masks. For other attendees, masking will be encouraged, but not required. LRF also strongly encourages that all other attendees and participants wear a mask during the event when not consuming food or beverages.
- Workshop and the Educational Forum presentations and the provision/consumption of food and beverages will take place in separate rooms. The consumption of food and beverages will only be allowed in designated dining areas. Please note that attendees will only be allowed to bring water with them into the presentation rooms.
- In both the presentation and dining rooms, there will be reserved tables/seating areas for attendees who are (or are with) lymphoma/CLL patients in active treatment or who have received immunosuppressive medications or treatments in the past 6 months.



- In the presentation room(s), masking will be required for all individuals seated in these reserved tables/seating areas.
- In the dining room(s), masking will be required for all individuals seated in these reserved tables/seating areas when not actively consuming food or beverages.
- Safety is at the forefront of LRF's event planning. Please note that any attendee who tests positive for COVID or reports possible symptoms after arriving to the venue will promptly be asked to leave the premises.
